Within the span of 20 years, he rose to the position of Regional Audit Director in AstraZeneca Plc UK (AZ) for Asia Pacific, Middle East, and Africa in mid-1998. As a part of the AZ Group Internal Auditor global senior management team, he was responsible for developing and charting the Group's governance strategy for SOX compliance in the US.

He was the past President of IIA Malaysia and the Asian Confederation of Institute of Internal Auditors and former board member of IIA Global. He was formerly a member of ACCA Malaysia's Advisory and past Chairman of Internal Audit Working Group of MIA. He won the prestigious Malaysian Internal Auditor of the Year Award in 2001 and was a speaker and chaired numerous international, regional and national conferences organized by professional bodies throughout his career in internal audit.
